A. AGENDA FOR DISCUSSION

22AC (A-1) Quality Mandate

Quality mandate as specified by UGC, in terms of graduate outcomes, promoting society and industry connect, upliftment of skilling, maintaining teacher student ratio and requirement of accreditation was deliberated upon. University's proactive initiatives to maintain quality in academics and research was appreciated. In this regard, the Council recommended that the UGC's guidelines be followed broadly.

22AC (A-2) Scholarships for Ph D Programme

With due approval of Executive Committee, University is in process to offer 60 scholarships for Ph D Programme for a maximum duration of three years i.e. 20 scholarships per year from admissions year 2018 onwards. The Council recommended to institute these scholarships in the name of Dr Ramdas Pai, Emeritus Chairperson, MUJ.

The Council appreciated the initiatives and suggested to frame guidelines for awarding the scholarships in terms of eligibility criteria, distribution of scholarship among the existing five Faculties. It was further suggested by the Council that the above scholarships be awarded semester wise.

- 6.3 Revised syllabus of Open Elective Course titled 'Social Entrepreneurship' (CM1493) offered by Department of Commerce from AY 2018-19.
- 6.6 Change of Course code of "Management Accounting" from BB1310 to BB1311 in the existing scheme of BBA programme
- 6.7 Syllabus of 2nd and 3rd year of BBA (Hospitality and Tourism) programme.
- 6.8 Modification in evaluation pattern of BHM programme from Admission 2018 as under:

 CWS: 20 marks MTE: 40 marks ETE: 40 marks
- 6.9 Modification in syllabus of Course titled 'Value, Ethics and Governance' (HS1101) from AY 2018-19 onwards. The Council further suggested to relook the course code and make required revision.
- 6.10 Revised Scheme and Syllabus of MBA programme from Academic Year 2018-19 as proposed.

22AC (B-7) Faculty of Arts & Law

7.1 Course Structure and Syllabi of Sociology subsidiary / minor courses for B.A (Hons) & B.A (Liberal Arts) was deliberated upon and in principle approval was accorded to implement from Academic Year 2018-19. The Council further suggested that Directorate Academics and Dy Registrar to revisit the entire scheme and syllabus of B.A (Liberal Arts) and submit a report on modus operandi of implementation of Sociology as subsidiary / minor course for B.A (Liberal Arts) programme.

- 7.4 Syllabus of 9th & 10th semester of BA.LLB (Hons) Programme from Academic Year 2018-19.
- 7.5 Change in the nomenclature of "Principles of Criminal Law II" to "Specific Crimes" in LL.M, (Criminal and Security Law Branch) from Admission 2018.
- 7.6 Revised Syllabus of Principles of Corporate Law in LLM, 1st semester (Corporate & Commercial law) from Admission 2018.
- 7.7 Revised syllabus of law of insurance in LLM, 1st semester (Corporate & Commercial law) from Admission 2018.

- C It was suggested that:-
 - (i) Nomenclature Principles of Criminal Law II LLM Semester II should be changed to Specific Crimes which was to be implemented from upcoming Semester ie Aug 2018.
 - (ii) Principles of Criminal Law in LLM Semester I members of BoS recommended to remove I & keep only as Principles of Criminal Law.
- D (i) Syllabus of Law of Insurance LLM Semester I was revised and suggestions given by members were incorporated.
 - (ii) Nomenclature Women and Law BA LLB(H) IX Semester Optional Paper should be changed to Women and The Law.

BoS recommended that the syllabi to be placed before the Faculty Board for approval and subsequently to be placed before the next Academic Council meeting.
