MINUTES:

At the outset, Prof. Richa Arora, Officiating HoD, welcomed all the members.

- 1. The new course structure and syllabi of BA English (Hons) was discussed in detail. A few suggestions made by the External and the Industry Expert in the BoS were incorporated and approved by members of the BoS. (Annexure A)
- 2. The members also discussed the syllabi of Ten New Courses in BA (Hons) English, Six Generic Elective Courses (English Subsidiary) for BA (Hons) Psychology/Economics/etc, and one Open Elective Course "English for Competitive Examination" (to be offered at Undergraduate level). The external and industry experts suggested certain changes in few of the courses, which were later approved by members of the BoS. (Annexure B)
- 3. The following revamped English courses (offered in other departments) were discussed by the member of the BoS:
 - i. LN11001 Communication Skills in English B.Tech Semester-I/II
 - LN11106 Communicative English BA (Hons), BBA, B.Com, B.Sc, BA J&MC, BPES) Semester-I
 - iii. LN11107 General English BA LLB (Hons) Semester-I
 - iv. LN11108 Design Communication FoD Semester-I
 - V. LN11130 Language Lab BA (Hons) English, BA (Hons) Economics, BA (Hons)
 Psychology, BPES, BA J&MC Semester-I

The same were approved after incorporating minor changes, as suggested. (Annexure C)

- 4. The members of the BoS also gave approval to offer **Elementary French**, an Open Elective Course, for the Engineering students only.
- 5. The members also approved LTPC 3104 for two French courses French for Beginners-I and French for Beginners-II. The courses French for Beginners-I and French for Beginners-III shall run in Semester III & IV (in any programme, wherever offered). The aforementioned courses were already approved in the 21st Academic Council.
- 6. The revamped syllabi of the following German courses were presented by Mr. Hemant Agrawal, faculty (German). An email approval was taken from the External Expert (German)
 - i. LN12082 Elementary German UG Open Elective (IV/VI Semester),
 - ii. LN15101 German B. Arch. (IX Semester)
 - iii. LN13203 Fundamentals of German BBA (VI Semester)

The members of the BoS approved the same. (Annexure D)

7. Adhering to the new guidelines circulated by the Directorate of Academics, all courses (English, French, and German) under the Department of Languages, have been allocated new

- course codes. From the Academic Session 2019-20, instead of the existing EN/FR/GR codes, a common Department Code 'LN' will come into effect. (Annexure E)
- 8. The members also discussed and approved the revamped syllabus of Certificate Course in German. (Annexure F)
