1. K.U.Leuven hereby awards the research fellow a grant amounting to 1.888,77 EUR bruto per month, from 1 November 2008 until 31 October 2009 included, to enable the performance of university-based post-doctoral research at K.U.Leuven in the context of interuniversity mobility, without the creation of any employment relationship, in accordance with the application submitted by the research fellow and with the funds specified in that application.
2. This grant is subject to the K.U.Leuven Rules on Research Fellows in International Mobility as approved by the Joint Research Advisory Bureau.
3. The research fellow hereby accepts the grant as awarded. He/she undertakes to dedicate him/herself to his/her research on a full-time basis. Accumulation of this grant with other income from professional activities, whether as an employee or in a selfemployed capacity, is not permitted. The grant will be subject to the Belgian social-security contributions (Social security law 27th of June 1969).
4. The research fellow is obliged to register with a Belgian health insurer of his/her choice. In the event of absence due to illness or accident, the research fellow will furnish the Personnel Department with a medical certificate without delay and will notify his/her academic supervisor. Payment of the grant may be suspended by decision of the Joint Research Advisory Bureau in accordance with the provisions of Article III.2.3 of the Rules on Research Fellows in International Mobility.
5. Professor Peter Lievens will act as academic supervisor. He/she declares not to impose any service assignments whatsoever on the research fellow.
6. The grant may be withdrawn if the research fellow is clearly falling short in the performance of the study or research work for which the grant was awarded. Such rescission will take place subject to a decision by the Joint Research Advisory Bureau, following a recommendation by the academic supervisor and after the research fellow has put his/her case to the Joint Research Advisory Bureau or has at least been invited to do so. The decision may entail compulsory repayment of all or part of the grant amounts that have already been paid. The research fellow may appeal to the Academic Council against a decision to withdraw the grant.
