

MEMORANDUM OF UNDERSTANDING

BETWEEN

MANIPAL UNIVERSITY JAIPUR

AND

CONVENER, CORE COMMITTEE, COMMON LAW ADMISSION TEST (CLAT) – 2017

ORGANIZING UNIVERSITY, CHANAKYA NATIONAL LAW UNIVERSITY, PATNA

FOR UTILIZATION OF CLAT-2017 UNDER GRADUATE EXAMINATION RESULT

This MEMORANDUM OF UNDERSTANDING (hereinafter referred as "MoU") made at Patna, on 23rd February 2017 BETWEEN **Manipal University Jaipur** on the ONE PART

AND

Convener, CLAT-2017 on behalf of CLAT Core Committee, which comprises of Vice-Chancellors / Directors of the seventeen participating National Law Universities, a sole authority for regulating the examination and declaring the result of CLAT (Common Law Admission Test), an all India Examination administered and conducted jointly by the member National Law Universities.

WHEREAS:

- (i) CLAT stands for Common Law Admission Test.
- (ii) **MUJ** stands for **Manipal University Jaipur**.
- (iii) Manipal University Jaipur, desires to utilize the CLAT **Under Graduation** and **Post Graduation** scores for the purpose of admission during the Academic Year 2017-18.
- (iv) Pursuant thereto **MUJ** and Convener, Core Committee, CLAT-2017 have worked out certain arrangements, as noted in this MoU with a view to utilize the CLAT-2017 **Under Graduate** and **Post Graduation** Examinations score for the admissions in **MUJ**.
- (v) The parties desire to record the terms and conditions and objectives of the utilization of said CLAT-2017 score incidental thereto agreed between them.

2. Actual CLAT Marks shall mean the marks (Out of 200) secured by candidates who have appeared for CLAT-2017 Under Graduation and Post Graduation Examinations.

3. "MUJ" shall mean Manipal University Jaipur.

NOW, THEREFORE, THIS MoU WITNESSETH as follows:

1. The Convener, Core Committee, CLAT-2017 will provide LOGIN ACCOUNT from wherein Actual CLAT-2017 Marks, Qualifying Marks All India Rank (AIR) and contact details of candidates appearing in CLAT-2017 can be accessed by **MUJ**.
2. The database accessed from LOGIN ACCOUNT shall be used by **MUJ** and it will not be shared by **MUJ** with any other University / Institution / College / Agency. This does not in any way preclude the Convener, Core Committee, CLAT-2017 from sharing the Actual CLAT marks with agencies other than **MUJ**.
3. The LOGIN ACCOUNT and database are provided only for the purpose of admission in **MUJ**.
4. **MUJ** shall take prior permission from the Convener, Core Committee, CLAT-2017, if **MUJ** desires to use the database accessed from the LOGIN ACCOUNT for the purpose other than that stated above.
5. This MoU does not allow the **MUJ** to have a say in the policies for conduct of CLAT-2017, such as syllabi, format pattern of examination, etc.
6. It shall be the responsibility of **MUJ** to verify the authenticity of the information provided by the candidates applying for admissions to **MUJ**. If any dispute arises with regard to the details of a candidate, the CLAT Office will share the details of the candidates available with it, such as particulars, address, photographs and other details with **MUJ**.
7. The Core Committee CLAT-2017 will not be concerned with the admission process of **MUJ**.
8. It will be the responsibility of **MUJ** to advertise / inform respective candidates that the **MUJ** will use the CLAT-2017 candidate's score for admission purpose. This information will not be included in the CLAT poster / advertisement / brochure. The **MUJ** shall pay Rs. 10,000/- to upload the name of institution in CLAT-2017 website as institution having MoU with CLAT-2017.
9. **MUJ** will be required to pay the Annual fee of Rs. 1,10,000/- (INR One Lakh Ten Thousand only) for up to 100 seats and for more than 100 seats Rs. 1,10,000/- + Rs. 1,000/- per extra seat to be filled excluding taxes, if applicable to the CLAT-2017. The sum shall be remitted to "**Convener, Implementation Committee CLAT-2017**", Patna either by way of bank draft or by electronic transfer.

10. The CLAT-2017 office will provide the above mentioned LOGIN ACCOUNT to access the details within 30 days of declaration of CLAT-2017 results subject to payment in advance with MoU from **MUJ**.

All the matters of dispute shall be subject to the jurisdictions of Patna Courts only. The parties shall use their best endeavors to settle any dispute or claim arising out of or relating to the MoU, in supplemental agreements and their attachments thereto through amicable discussions. If not amicably settled within sixty (60) days of the dispute or claim arising, such dispute or claim shall be decided by a sole arbitrator to be appointed by the mutual consent of the parties in accordance with the provisions of the Indian Arbitration & Conciliation Act, 1996. The parties agree that the decisions of the arbitrator so appointed shall be final and binding upon the parties. The venue for Arbitration shall be Patna.







