Memorandum of Understanding

Between

The Board of Trustees of Illinois State University Normal, Illinois, USA

And

Manipal University Jaipur Jaipur, Rajasthan, India

- 1. The Board of Trustees of Illinois State University and Manipal University Jaipur, desiring to develop academic exchange and cooperation in teaching, research and training for the advancement and dissemination of learning hereby agree to implement, within the framework of the regulations applying in each of the institutions and subject to the availability of resources, the following programs and activities:
 - Exchange of faculty and staff
 - Exchange of students
 - Training and joint research activities
 - Exchange of academic materials and other information
- 2. The terms of such mutual assistance and the necessary budget for each program and activity implemented under the terms of this agreement will be mutually discussed and agreed upon in writing by both parties prior to the initiation of the particular program or activity.
- 3. The institutions acknowledge that all exchanges, visits of faculty and staff, teaching, research, and the admission of students will be subject to compliance with applicable state and federal laws, entry and visa regulations, and export laws of the United States of America and India, and the institutions' policies and practices.
- 4. The administration of this agreement shall be the responsibility of the Director of the Office of International Studies and Programs, Illinois State University and the Director, International Collaborations, Manipal University Jaipur.
- 5. This Memorandum may be amended by written agreement between the two institutions. Such amendments, once approved by both institutions, will become part of the Memorandum of Understanding.
- 6. This Memorandum represents no financial obligations to either Illinois State University or Manipal University Jaipur

- 7. This Memorandum will be in effect for three (3) years from the date of the last signature. It may be extended or revised upon written approval of both institutions. It may also be terminated by either party giving 180 days prior notice to the other party in writing of such termination.

It is understood and agreed that neither party to this Memorandum shall be liable for any negligent or wrongful acts, either of commission or omission, chargeable to the other, unless such liability is imposed by law, and that this Memorandum shall not be construed as seeking to either enlarge or diminish any obligation or duty owed by one party against the other or against a third party.
