MEMORANDUM OF UNDERSTANDING

between

MANIPAL UNIVERSITY JAIPUR

and

CENTRAL INSTITUTE OF PLASTICS ENGINEERING AND TECHNOLOGY JAIPUR (RAJ.)

MANIPAL UNIVERSITY JAIPUR (hereafter referred to as MUJ) DehmiKalan, Off Jaipur-Ajmer Expressway, Jaipur-303007 (Rajasthan) and **Central Institute of Plastics Engineering & Technology Jaipur**(hereafter referred to as CIPET) SP-1298, Sitapura Industrial Area, Phase-III, Tonk Road, Jaipur-302022 (Rajasthan) believing the extension and strengthening of academic exchange and co-operation to be of mutual value to MUJ/CIPET and to the development of understanding between our people, hereby record their intentions to promote academic, research and training between their institutions through the following activities:

1. STAFF EXCHANGE

1.1 **Visiting Academic Staff:** Each Institution may invite faculty members of the other institution for the purpose of lecture or consultation and/or research guidance for a specified period of time, subject to the approval of the host institution. In such case, the host institution shall make appropriate funding arrangements agreed to in advance.

2. STUDENT EXCHANGE

2.1 **Exchange of student:** Each institution may send students, undergraduate/post-graduate/research to the other institution in appropriate field of study, on terms & conditions, as mutually agreed.

2.2 Both institutions agree for the exchange of CAD/CAM Program i.e AUTOCAD, Creo, CATIA, UE NX, SOLID WORK, SOLID EDGE, ANSYS, CNC MACHINE etc. OR any other training programme for undergraduate/Degree/Ph.D students which should follow the educational system and regulations of the counterpart institution. Such students must submit their applications to the other through their own institution. **The payment terms will be decided by both the institutions as per mutual agreed terms.**

2.3 Both institutions agree to exchange students for which a separate students exchange agreement will be developed to formalize this aspect of the collaborative arrangement as may be mutually agreed in terms & conditions.

3. EXCHANGE OF ACADEMIC MATERIALS

3.1 Each institution agrees to exchange materials, relevant to activities/training.

4. TERMS OF COOPERATION

4.1 The term of co-operation for each specific activity implemented under this Memorandum of Understanding shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity.

4.2 Any such agreement entered into, as outlined above, will form an Appendix to this Memorandum of Understanding.

4.3 **Length of Agreement.** This MoU will remain in force for a period of one year extendable on yearly basis subject to the availability of funds and adherence to the terms of cooperation by mutual consent.

4.4 **Accountability.** An annual activity report shall be submitted by the lead coordinates to each of the institutions designated representative.


