

# Memorandum of Understanding



between

## Manipal University Jaipur, India

and

## Széchenyi István University, Győr Hungary

This document was drawn up on the basis of mutual scientific and cultural interests between the above-mentioned institutions, with the wish to deepen and strengthen their co-operation, under the following conditions:

#### Article One

In the areas of mutual interest, both institutions aspire to deepen their relationship. In the spirit of this, both institutions will do their best to form co-operation between their institutions, faculty and students.

## Article Two

The signatories urge further co-operation in the following areas:

- 1. The exchange of scientific experience in the areas of common interest on the basis of the invitation of faculty to departmental programmes to give
- 2. The exchange of experience with regard to the development of B. Sc., M. Sc., Ph. D and other educational exchange programmes.
- 3. The organisation of meetings, symposia, seminars and other programmes to be held in common.
- 4. The exchange of experience with regard to co-operation between companies and tertiary educational institutions.
- 5. The participation in scientific meetings organised by the signatories or other tertiary educational institutions.
- 6. Neither party assumes any obligation to cover incurring expenses, such as travelling or accommodation costs. However, both parties strive to support these in proportion to their financial means.
- 7. The exchange of students: Both institutions declare their readiness to receive the students of the partner institution, already in the academic year of 2016/2017. The parties strive to achieve balance in the student exchange programme in the long run. The exchange of students can be realised in the framework of e.g. EU

exchange programmes. Guest students of the partner University do not pay a study fee to the receiving institution for study (1 or 2 semester in a curriculum related exchange program). In the case of other courses (e.g. preparatory courses and postgraduate courses). leading to a degree or certificate, the students are not exempt from the fee.

The signatories mutually recognise students' examination results obtained at the receiving institution, provided the curriculum has been controlled by an authorised person.

#### Article Three

The signatories will examine the possibility of developing common training programmes taught by faculty of the partner institutions.

## Article Four

The signatories will examine the possibility of developing common research programmes in areas of mutual interest.

### Article Five

The signatories will examine the possibility of scientifically and professionally supporting the graduate students of the partner institution through further training programmes.

### Article Six

In order to ensure the success of the exchange as well as the rights of those participating in it both parties undertake an obligation to observe the following fundamental principles:

 Széchenyi István University, Hungary and Manipal University Jaipur, India agree to select exchange participants on the basis of achievements, regardless of any discrimination based on race, nationality, ethnicity, religion, age, sex, marital status or physical disability.

 Participants will be selected on the basis of study and professional requirements which both signatories judge to be acceptable. Selection is made by the delegating institutions on the basis of mutually developed criteria.

 insofar as basic principles are demonstrably violated, both parties are entitled to terminate the Memorandum of Understanding without delay.

### Article Seven

This Memorandum of Understanding was formulated in English.
