## MEMORANDUM OF UNDERSTANDING (MOU)

between

**T&R Consulting Pty Ltd, Australia**

and

**Manipal University Jaipur, India**

THIS MEMORANDUM OF UNDERSTANDING (hereinafter referred to as "MOU") is by and between T&R Consulting Pty Ltd, a Company incorporated under the Companies Law in Australia, education arm of TRUE Global Group, having its registered office at Suite 410, Royal Domain Corporate, 370 St Kilda Rd, Melbourne, VIC -- 3004, Australia (hereinafter referred to as "T&R") and Manipal University Jaipur situated in India (hereinafter referred to as "MUJ"). This MOU is effective on the date of the last signature by the authorized officials of the two parties.

NOW THEREFORE, for the purposes of framework for promoting training and research activities for MUJ, their faculty and students:

and in consideration of the mutual promises and covenants herein contained, the parties hereto agree as follows:

### BASIC UNDERSTANDING AND OBJECTIVES:

T&R and MUJ have a mutual desire to develop and execute education services & collaboration activities of the University's research projects, training programs such as SAP, value added programs & promoting e-learning management system for MUJ under this MOU.

Activities will be planned jointly by representatives of T&R and MUJ. Both parties entering this MOU anticipate a continuing effort. Activities will be identified individually as Services under this MOU, and all conditions established in the MOU shall apply to each Service.

The Services will be governed by additional terms as necessary and agreed upon by T&R and MUJ for specific Services and other mutually agreed upon financial terms. The Services shall be based on mutually approved individual work plans and accompanying budgets. Each Service shall contain functional needs and project details, such as purpose, scope of work, schedule, the enactment characteristics of the training program, e-learning management system, value added programs, research and other items.

In continuation of the good work done so far and to accelerate the growth of the University further, MUJ has signed an MOU with T&R, Australia to provide greater opportunities and enable students to be trained on SAP and other cutting edge technologies, use the learning management system, faculty and researchers to execute various projects, research activities, University collaborations and exchange ideas with the International fraternity.





This MoU shall be the bearing for future agreements governed by, construed by, and enforced in accordance with the internal laws of the state/country.


