## MEMORANDUM OF UNDERSTANDING

## **BETWEEN**

AND

Manipal University Jaipur, Jaipur - 303007

### **PREAMBLE**

Whereas, Bhagwan Mahaveer Viklang Sahayata Samiti (BMVSS) Jaipur - 302017 has been fabricating Jaipur Foot & Limb and helping the physically differently abled persons. The organization has been continuously eager to develop/adopt newer technologies for furtherance of performance, affordability and quality of its products.

WHEREAS, Manipal University Jaipur (MUJ), Post: Dehimi Kalan, Jaipur - Ajmer Expressway, Jaipur - 303007 is engaged in academic activities in various disciplines in engineering, technology, sciences etc. as well as research, design and development in these fields.

### WHEREAS, both BMVSS and MUJ, now

- Recognizing the importance of research and development in the areas of science, engineering & technology, etc.
- Desiring to club their efforts by pooling their expertise and resources

INTEND to join hands for promoting excellent quality products especially the low cost Jaipur Hand by utilizing state of the art engineering, technology and science.

NOW, THEREFORE, in consideration of the mutual promises made herein and of good and valuable consideration, the receipt and sufficiency of which both BMVSS and MUJ hereby acknowledge and agree to sign a memorandum of understanding (MOU).

### ARTICLE-I: SCOPE OF THE MOU

This MOU details the modalities and general conditions regarding collaboration between BMVSS and MUJ for enhancing the engineering, science and technology inputs without any prejudice to prevailing rules and regulations in BMVSS and MUJ without any disregard to any mechanism evolved and approved by the competent authorities. The areas of cooperation can be extended through mutual consent.

### ARTICLE-II: SHARING OF FACILITIES

- a) BMVSS and MUJ shall make provisions to share their respective important R&D facilities in order to promote research interaction in the areas of cooperation.
- b) BMVSS and MUJ shall permit the sharing of software and other materials and components developed in-house in the areas of cooperation, if permissible within the rules governing the two institutions. However, responsibility for safety of





- software and other materials during the exchange will rest on respective Head of academic department/section.
- c) BMVSS and MUJ shall provide access to the library facilities to scientists, members of faculty and students as per the prevailing rules and norms in the respective institutes.

# ARTICLE-III: CO-ORDINATION OF THE PROGRAMME INCLUDING FINANCIAL ARRANGEMENTS

- a) The collaborative programme between BMVSS and MUJ shall be coordinated by a coordination committee appointed by the Heads of both the Institutions.
- b) Financial arrangements for each specific collaboration will be decided on a caseto-case basis and brought on record in each case after due approval from heads of both the Institutions.

## ARTICLE-V: EFFECTIVE DATE AND DURATION OF MOU

- a) This MOU shall be effective from the date of its approval by competent authorities at both ends.
- b) The duration of the MOU shall be for a period of 5 years from the effective date.
- c) During its tenancy, the MOU may be extended or terminated by a prior notice of not less than six months by either party. However, termination of the MOU will not in any manner affect the interests of the researchers who are engaged under the MOU.
- d) Any clause or article of the MOU may be modified or amended by mutual agreement of MUJ and BMVSS.

### ARTICLE-VI: IPR

Rights regarding publications, patents, royalty, ownership of software/design/product developed etc. under the scope of this MOU, shall be decided by the two parties by mutual consent.

### ARTICLE-VII: CONFIDENTIALITY

During the tenure of the MOU both partners will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for any purpose other than in accordance with this MOU.
