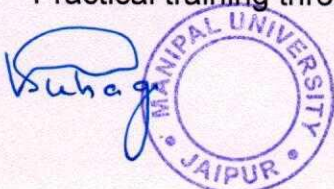

The activities and services for the initiative shall include.


a) Service to be rendered by Hotel Clarks Amer & Convention Centre Jaipur:

As knowledge partner to the Professional Hotel Education Program under Clarks Centre of Excellence –providing theoretical exposure to the students.


