

**MEMORANDA OF UNDERSTANDING**  
**for**  
**ACADEMIC COOPERATION**  
**between**  
**CALIFORNIA STATE UNIVERSITY MONTEREY BAY**  
**And**  
**TAPMI SCHOOL OF BUSINESS, MANIPAL UNIVERSITY JAIPUR**

**1.0 EFFECT**

California State University Monterey Bay (CSUMB) in the USA and TAPMI School of Business, Manipal University Jaipur (MU) in India have concluded this Agreement in recognition of the mutual benefits accruing to their academic communities from the establishment of strong international links.

**2.0 PURPOSE**

The purpose of this Agreement is to contribute towards the development of research and education of both Universities through their academic collaboration.

**3.0 CONTENT OF AGREEMENT**

For the purpose of this Agreement, the general areas of interest to the partners are collaboration and exchange of knowledge in the areas of common interest as follows:

- 1) Exchange of faculty members and students for study and research
- 2) Execution of joint research projects
- 3) Exchange of information and academic publications
- 4) Other programmes acceptable to both Universities
- 5) Encouragement of the exchange of graduate and undergraduate students for research, learning, and internship

Any decision to participate in activities noted above shall be subject to a further appropriate and signed agreement.

**4.0 RESPONSIBILITY FOR COSTS**

Financial arrangements for collaborative activities will be agreed upon a case by case basis.

**5.0 VALIDATION PERIOD**

This agreement shall be in effect for five years from the date of its signing and may be renewed upon written mutual agreement between both parties.

**6.0 REVISION**

- 6.1 This agreement shall be amendable by mutual negotiation, six months prior to its expiration, when the amendment is based upon the proposals of operational representatives of either University.
- 6.2 The validation date of the revised agreement shall be the day of its signature by representatives of both Universities.
- 6.3 If any of the activities specified in Article 3 are to be affected by the aforementioned revision, the prior agreement shall be applied.

**7.0 TERMINATION**

This agreement shall be terminated by either party giving written notice of termination to the other party not less than six months prior to the expiry date.

**8.0 ORIGINAL DOCUMENT PROTECTION**

The text of this agreement is written in English with a copy for both Universities.
