11 URC (D) Items for Discussion and Decision:

a. Proposed amendments in Ph.D. Regulations:

In meeting of Deans/Directors held on October 27, 2015 some modifications were suggested in the existing Ph.D. Regulations. Those were put up in the URC meeting. URC committee members deliberated and recommended to make amendments in Ph. D. rules as follows:

- (i) Eligibility for Ph.D. degree: It was clarified that a candidate would be allowed to register in Ph.D. in a department relevant to his/her field of study, but the degree would be given from the faculty in which he/she is eligible. The topic, however, could be interdisciplinary.
- (ii) The candidate will submit four soft bound copies (in place six hard bound copies) of Ph. D. thesis along with a CD initially.
- (iii) These would be sent by CoE to one foreign and two Indian examiners, as identified by the URC Chairperson in place of one foreign and one Indian examiner besides internal supervisor.
- (iv) If any modifications/corrections are suggested by the examiners, then they would be incorporated by the scholar and will be reported in the viva-voce if the candidate accepts. However if the candidate desires to contest, he/she will have to do so in Viva-Voce examination. Depending on the recommendation of the Viva-Voce examination, the candidate will have to do the necessary action.
- (v) After viva-voce scholar is required to submit corrected 3 hard bound copies of thesis with new CD to CoE.
- (vi) The final bound copy would be kept in the Library, Department and CoE office. Soft copy will be forwarded to UGC by the CoE.

9 URC (F) Any other matter with permission of the Chair:

- 1. It is decided that from now onwards that part time research scholar can submit their final research proposal within 24 months of time whereas full time needs to submit within 18 months of time from the date of provisional registration.
- 2. Notification of Ph. D. viva voce should be sent to UGC and AIU within 15 days of conduct of viva voce through CoE.
- 3. Every six month, all research scholars are required to do academic registration, failing which their registration may be cancelled.
- 4. Re-admission of any research scholar, whose Ph. D. registration has been cancelled, can be done by taking Rs. 5000/- re admission charges.
- 5. Office orders of any kind of changes in the registration of research scholar should be generated through Ph. D Coordinator and copy of the same need to be marked to all concerned.
- 6. Excel sheet of activities needs to be prepared for all research scholars and it should be given to them with registration letter.
- 7. NET/M.Phil./GATE qualified candidates are also required to appear in Ph.D. entrance examination.
- 8. The request of Mr. Dhiraj Pandey to allow him to complete his RM Course under self-study mode was accepted as he had already fulfilled residential requirement.
- 9. The request of Ms. Joyita Sinha to exempt her from appearing in entrance test was accepted as she was already registered in Vidhyasagar University, West Bengal and completed her Ph.D. course work from there.
