12URC (D-5) Minor modification in Ph.D. regulation rule no. 7.2

The URC committee members deliberated on the provision of rule no. 7.2.1 and 7.2.2 and recommended minor modifications in Ph.D. regulations. According to the recommendation rule 7.2.1 is to be read as:

Work after provisional "A11 Course research scholars must earn credits through registration, as part of the Ph.D. programme in the first year. The number of credits to be earned is 8-12, out of which a 4-credits course on Research Methodology will be compulsory. The other 4-8 credits could be earned through one Seminar (2 credits) or Courses (taught/selfstudy) (Max 4 credits each). However, for candidates with M.Phil. degree, the course on Research Methodology may be exempted."

12URC (D-6) Amendment in the guidelines for Ph.D. programme to be renamed as Ph.D. programme ordinance instead of regulations

Committee suggested that Ph.D. programme regulations be named as Ph.D. Rules and Regulations.

12URC (D-7) Proposal to maintain the record of attendance for full-time research, scholars in respective departments

It was approved that HoDs would keep the daily record of attendance of full time research scholars and at the end of the month, compiled attendance should be sent to Ph. D. office for record. The record will be examined by the concerned Director of the school.

12URC (D-8) To finalize date of next Ph.D. entrance exam date (proposed June 4, 2016)

The following schedule was approved by the committee for conducting the next Ph.D. entrance examination:

12URC (D-9) To increase amount of contingency grant for research scholars and provision of the same for part-time research scholars

The committee approved the proposal to increase amount of contingency grant from Rs. 10,000/- to Rs.12000/- to be effective from July 2016 onwards for full time research scholars but the provision of the same for part-time research scholars was denied.

12URC (D-10) To make allocation of suitable grant for research work such as testing / characterization / samples etc.

The committee did not approve separate allocation of suitable grant for research work such as testing / characterization / samples etc. However, it was recommended that scholars could use the finances available





with department or PDA grant of the supervisor, if necessary. Guidelines for the same will be issued separately.

12URC (D-11) To consider enhancement in the amount of Teaching Assistantships

The committee approved increase in the amount of Teaching Assistantships from Rs. 12000/- to 15000/- per month to be effective from July 2016 onwards.

12URC (E) Any other matter with permission of the Chair:

- It was proposed that at the time of submission of thesis, a separate submission fee should be charged.
 A committee will be constituted to recommend the same for further approval.
- 2. It was recommended that the honorarium for evaluating Ph.D. thesis be revised as under: From Rs. 5000/- to Rs. 4000/- for reading thesis and from Rs. 1000/- to Rs. 2000/- for Viva-Voce examination to be effective from July 2016 onwards.
- 3. From now onwards, concerned Deans and Directors be also invited for DRC meetings of the department.
- 4. Supervisors should propose names of 6 examiners from India instead of 5 examiners for evaluation of Ph.D. thesis.
