6URC (A) URC confirmed the minutes of 5th URC meeting held on 24th August, 2013 as no comments were received on the same.

6URC (B) Report on action taken on 5th URC was presented and noted.

- **6URC (C)** (1) It was decided that the fees for extension (six month wise) for thesis submission will be half of the annual fees for present batch.
 - (2) It was decided that from now onwards the fees for the first two years will be charged annually and there after semester wise on pro-rata basis.

6URC (D) The following decisions were taken on applications received for URC consideration:-

- (1) Mr. Hemen Deve was granted a six month extension for thesis submission as requested from 20^{th} Sep. 2013, with prescribed fees decided in 6 URC (C) (1).
- (2) For Ms. Deepika Sharma, Dr. Lalita Ledwani was asked to assess the necessity of having Dr. M.M. Sharma as co-guide. She was also advised to explore whether the new faculty of Bio-Sciences could be suitable for the same.
- (3) Ms. Jyotika Sharma's, request for full-time candidature was accepted. Her part-time candidature of last 6^{th} months would be counted as 3 months as a full-time candidate.





Therefore, she has to work for a minimum of 21 months to submit her thesis from the date of decision taken.

(4) Maj. Gen. Ajay Kumar Chaturvedi was granted permission to complete his balance mandatory residential requirement before the submission of his synopsis, as residential requirement was compulsory as per UGC regulations. It was also decided that in his case, Dr. Anurag Bhatnagar would be the main guide and Brig. Siwach would be the coguide, as he is external to MUJ.

Under any other item:-

- (1) It was decided that the research topics allotted to students of M.Sc. (Research) will also be reported to URC.
- (2) It was decided that a Research and Innovation Cell will be constituted according to the decision of the Academic Council.
- (3) Prof. B. K. Sharma, Dean Research & Innovation was requested to organize a workshop on 'Developing strategies and patents', with the help of external experts involved in these activities, for faculty & students of MUJ.
