- e. Request for changing the candidature from full-time to part-time in Ph.D. programme:
 - (i) The recommendation of DRC in favour of Mr. Deshraj Meena and Mr. Shravan Kumar Khoda (Research Scholars, Department of Hindi) for the change of candidature from full-time to part-time was placed before the committee and the committee approved the same. It was decided that the stipulated minimum thesis submission time will be two and half years for both the scholars on pro-rata basis.
 - (ii) Likewise request of Mr. Jai Prakash Asopa (Research Scholar, Department of Management) for change of candidature from full-time to part-time was approved as recommended by the DRC for the same. It was decided that the stipulated minimum thesis submission time will be two years for him on prorata basis.
- f. Non-compliance of the submission of final research proposal:

The Committee noted with dissatisfaction that some research scholars have not yet submitted their final research proposals. They may be allowed to submit the same by April 30, 2015 giving due valid reasons through their respective SDC and DRC.

g. Non-compliance of the submission of six month progress report: Committee decided that the research scholars who have not submitted their six month progress report may be allowed to submit it till 28th February 2015, on written request with valid reasons through their respective SDC and DRC.

- h. Advance registration in Research Methodology course work for internal faculty members:
 - (i) It was decided that internal faculty members may be allowed to attend the Research Methodology course work with registered research scholars but they cannot appear in the exams without getting registration in Ph.D. programme.
 - (ii) A certificate will be issued by the Ph.D. section to the faculty members who are attending the RM course without getting registration in Ph.D. programme.
