The meeting began with the welcoming of the members of Academic Council.

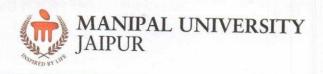
The Chairman gave a warm welcome to the new members of Academic Council.

A. AGENDA FOR DISCUSSION

41AC (A-1): Faculty of Law (FoL)

- Minimum threshold of eligibility criteria for qualifying marks should be $60\,\%$ or more for (UG Programs: BALLB/BBALLB) and $55\,\%$ or more for LLB and LLM programs.
- Entrance Exam to be conducted by the Faculty of Law, MUJ, in collaboration with Faculty of Law, MAHE.

Dean, FoL, presented the agenda stating that increasing the eligibility criteria of qualifying exam marks for UG & PG Law programs will help in getting good quality of students.

The council gave in-principle approval with the following suggestions:

- Dean FoL to have a meta-analysis on the data of how many students got admission in the previous years with 50-60% marks in the qualifying exam and who couldn't secure admission though having more than 60% marks in the qualifying exam.
- Dean, FoL, should immediately get touch base with Dr Sarasu Thomas, Director, Manipal Law School, and deliberate on the eligibility criteria of qualifying marks and to have a common entrance exam for admission in Law programs in MAHE campuses & MUJ.
- The eligibility criteria of qualifying marks must be well defined like how much weightage
 (%) of marks must be considered from qualifying exam and entrance exam.
- The structure / pattern of common entrance exam like the number of sections, number
 of questions, total marks, exam duration, type of questions preferably MCQs, must be
 clearly drafted.
- Dean, FoL, MUJ and Director, Manipal Law School, must come up with a joint proposal
 in this regard at the earliest possible and get it routed through Vice Chancellors of MAHE
 & MUJ for their consent and further approval.
- Upon approval, this has to be immediately notified to admission teams at MUJ & MAHE to go for parallel admissions.

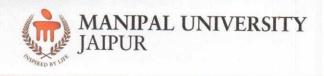

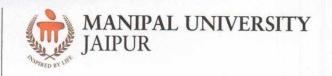

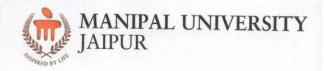
