The meeting began with the welcoming of the members of Academic Council.

A. AGENDA FOR DISCUSSION

30AC (A-1): Introduction of New B Tech Programmes for AY 2021-22 & onwards with:

- Splitting of the existing intake for
 - BTech (Hons) Civil Engineering with specialization in Geoinformatics, offered by department of Civil Engineering.
 - BTech (Hons) Chemical Engineering with specialization in Computer Aided Process Engineering (CAPE), offered by department of Chemical Engineering.
 - BTech (Hons) Mechanical Engineering with specialization in Robotics, offered by department of Mechanical Engineering.

Introduction of new BTech (Hons) programmes with splitting of the existing intake for some programmes was discussed in detail. It was informed that Department of Chemical Engineering has come up with a proposal to offer one more program BTech (Hons) Chemical Engineering with specialization in Petroleum Engineering with an intake of 20. It was further informed that offering of the Petroleum Engineering specialization was discussed in the preliminary meeting and BoS will be conducted before announcing ht programme. It had been discussed in detail in the preliminary meeting, but BoS could not be conducted. So, an in-principle approval for the same was requested. Further, it was also conveyed that these programmes may not go for AICTE approval as these programmes are being offered with in the existing intake.



Additional intake for

- B. Tech (Hons) Computer Science and Engineering with specialization in Artificial Intelligence & Machine Learning, offered by department of Computer Science and Engineering.
- B. Tech (Hons) Computer Science and Engineering with specialization in IoT and Intelligent Systems, offered by department of Computer and Communication Engineering.
- . B. Tech in Electrical and Computer Engineering, offered by department of Electrical Engineering.

Introduction of new BTech programmes with additional intake for some programmes was proposed. It was informed that these programmes will have to go for AICTE approval as these programmes are being offered with additional intake. It was also informed that a student after completing second year of his/her BTech (Hons) or normal BTech programme would be given the flexibility to either continue or switch to normal BTech programmes or vice-versa. For this, proper counselling of the student will be done by the concerned department.

The proposal was noted and approved in-principle by the Council.

Registrar, Evaluation, MAHE (external member) mentioned that MIT is also starting with new B Tech programmes with specialization. In this regard, it was proposed to have a joint meeting of the team from MIT with their counterparts in MUJ to discuss about the title of the programmes and other details.

- M Tech in Industrial Automation and Robotics to be offered by the department of Mechatronics Engineering.

Considering the recommendation of Faculty Board of Faculty of Engineering, the Council approved the introduction of the two new M Tech programmes, with the suggestion that for the students to have energy auditing certification, two electives courses on Electrical and Thermal Auditing can be included in the curriculum and offered by Department of Electrical Engineering.

reduction in the approved intake, the department should also think to offer new such programmes which are more contemporary and are as per industry needs.

Case of a Student Mr Ankit Pareek (Reg No:181201028) was reported, who was admitted in BA(J&MC) programme in 2018 with 150 credits, but due to some unfortunate circumstances, when he joined back in his second year, the curriculum had got revised to 132 credits. Revision of academic scheme with reduced credits for him to earn a degree of BA(J&MC) was proposed before the council.

The same was approved with a suggestion that any student who gets admitted in the next batch with revised curriculum, needs to complete the degree with the revised scheme only including the number of credits. Some of the courses can be mapped to match equivalency and can be offered to the student.

30AC (D-1) Proposal to run Joint Courses by exchanging faculty members between MAHE Dubai and MUJ

To initiate a full-scale exchange between MUJ and MAHE Dubai, it was proposed to jointly teach a few courses for B. Arch and B. Des programmes by exchanging faculty members. In order to cater to the same, approval of the following points from the Council was proposed:

- Issuing mark sheets for the course ID: ARC-14-312, ACR-14-406.4 and DOD 2104 for the students
 of MAHE DUBAI.
- MUJ will only issue a letter for the MAHE DUBAI Students (for CoE) that contains the total marks
 each student has scored out of 100 marks.
- MAHE Dubai will acknowledge it and give the grades accordingly as per their academic rules. MUJ
 will accept the mark-sheets for Course ID AR1606, AR1805-4 and ID 2202 issued by MAHE Dubai
 for the students of MUJ and grade it as per MUJ rules.
- Our faculty members will be permitted to teach courses at MAHE Dubai as a part of this exchange, and faculty members of MAHE Dubai will be allowed to take our courses in B. Arch and B. Des programme. However, internal faculty members of both institutions, will be a part of each class for support.
- As this initiative is a pilot, the Departments may have to run this on manual mode (excluded for DMS)
 at least for one academic year.

The council noted and ratified the same.
