The meeting began with the welcoming of the members of Academic Council.

A. AGENDA FOR DISCUSSION

35AC (A-1): Controller of Examinations

35AC (A-1-1) Proposal to reduce the passing marks in ETE to 25% and 30% respectively for UG and PG programmes instead of current 35% for UG and 40% for PG programmes (from next academic year 2023-24).

The Controller of Examinations while presenting the result analysis for the AY 2021-2022 suggested that bringing down the % of minimum marks required to pass in ETE to 25% and 30% might lead to 1% increase in the passing percentage of students.

Based on the inputs by CoE, the Council suggested the following:

- Before result announcement, discussion at the top level must happen before publishing the results.
- Bringing down the passing marks percentage in ETE may lower the quality of evaluation which in turn may lead to the poor performance of the students and might have a negative impact on the recruitment.
- It was decided not to reduce the percentage of minimum marks to pass in the ETE for UG & PG programmes and stick on to the present marking guidelines.

35AC (A-1-2) Conduction of PhD Viva-Voce: Offline/Online

The Controller of Examinations placed before the Council the agenda on whether to conduct the PhD Viva-Voce Examination in Offline/Online mode.

After much discussion, the Council suggested the following:

- The PhD Viva-Voce has to be conducted in offline mode just after the 9th Convocation of MUJ.
- DoR/CoE, MUJ, instead of asking the external PhD examiner to take the Viva-Voce in Online/Offline mode, should allow the external PhD examiner to conduct the viva in online mode if he/she is unable to come to MUJ campus for genuine reasons.
- All the PhD scholars of that particular department or School must attend the PhD Viva-Voce of PhD candidates who will be defending their thesis.
- The announcement regarding PhD Viva-Voce of a candidate has to be floated to MUJ Faculty through Exchadmin at least a week before the defense.

35AC (A-2): Faculty of Engineering

35AC (A-2-1) Proposal of offering B.Tech (Non computing branches) with Minor Specialization in CSE

- 1) B.Tech (Chemical Eng.) with Minor Specialization in CSE.

Dean, FoE, proposed the idea of offering B.Tech with minor specialization in Computer Science for non-computing branches.

The Council suggested the following:

- Overloading of teaching workload of the faculties or need for more faculties has to be looked into.
- All the students from core non computing branches who wish to opt for this minor specialization can be grouped in a single section to take the extra courses.
- Instead of offering a minor specialization in Computer Science which is indeed a major branch, it's better to narrow down and offer such minor programmes which

are more specific (like IoT, Blockchain, Cyber Security, VAR, etc.) and also has scope of employability in the job market.

- Should also check the regulatory body's (AICTE) guidelines for degree nomenclature of such minor specialization programmes.
- Departments can come up with their own minor specializations focusing on the job market.
- This can be initiated in the next Academic Year with more deliberations / planning in the coming days.
