Sir,

With reference to your e-mail dated 07.02.2023 on the subject cited above, I am directed to inform you that the Manipal University, Vatika Infotech City, Near GVK Toll Plaza, Jaipur ajmer Experss Way, Post – Thikaria, Jaipur – 302 026, Rajasthan has been established by the Act No.21 of 2011 of State Legislature of Rajasthan as a Private University. The University is empowered to award degrees as specified by the UGC vide Notification on “Specification of degrees, 2014” and its amendments issued from time to time under Section 22 of the UGC Act, 1956, through its main campus in regular mode with the approval of Statutory Bodies/Councils, wherever required, after creating required academic and physical infrastructure facilities including library, laboratories and appointment of teaching and supporting staff as per the norms and standards laid down by UGC and other relevant Statutory Council(s). The name of University has been included in the list of Universities established as per Section 2(f) of the UGC Act, 1956 as maintained by the UGC.

Manipal University, Jaipur, Rajasthan is not authorized to open study centre/ off campus centre beyond the territorial jurisdiction of the state as per the judgment of Hon'ble Supreme Court of India in case of Prof. Yashpal vs. State of Chhattisgarh. The University cannot open its centre(s) even within the state as per the provision of UGC (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003 without the approval of UGC.

The UGC has not granted any approval to the University to open off campus/study centre.

The University cannot offer its programmes through franchising arrangement with private coaching institutions even for the purpose of conducting courses through distance mode.
